All programs accredited by the Council on Social Work Education's (CSWE) Commission on Accreditation (COA) are required to measure and report student learning outcomes. All students are assessed using a minimum of two measures on their mastery of the nine competencies that comprise the Educational Policy and Accreditation Standards (EPAS) and any additional competencies programs may choose to add. These holistic competencies reflect the dimensions (knowledge, values, skills, and cognitive & affective processes) of social work practice that all social workers are expected to master during their professional training.

Programs determine a percentage-based benchmark for each competency and determine an outcome-measure benchmark (minimum score) for each measure. The competency benchmark (which can differ for each competency) represents the minimum percent of students the program expects to have achieved the outcome measure benchmarks in both/all measures for each of the nine competencies. The program then determines the percentage of students that attained each outcome measure (e.g., minimum score or higher), and aggregates the percentages for both/all measures together to obtain the percentage of students demonstrating competence inclusive of two (2) or more measures. The result of aggregating both/all outcome measure percentages provides the percentage of students achieving the competency benchmark. An aggregated percentage at or above the competency benchmark is considered achievement of that competency. If the program has more than one program option, the program must report data for each program option, and also an aggregate of all program options combined to determine an overall percentage of students across all program options achieving the competency benchmark.

Summary of the Program's Assessment Plan

At its June 2021 meeting, the Commission on Accreditation of CSWE voted to reaffirm the accreditation of the BYU MSW program for eight years (June 2029).

All students are assessed using a minimum of two measures on their mastery of the nine competencies that comprise the Educational Policy and Accreditation Standards of the Council on Social Work Education and any additional competencies programs may choose to add.

Because BYU's MSW classroom curriculum, Integrative Field Seminars, field internship learning activities, and field evaluations are all correlated with CSWE's competencies, holistic competency dimensions, and practice behaviors (for field education), the theoretical and conceptual contribution of the classroom is closely connected with the practice setting and fosters the implementation of practice-informed research and research-informed practice. Thus, the purpose of continual assessment is to evaluate if MSW students have developed the knowledge, values, skills and cognitive and affective processes necessary at the generalist and specialized practice levels to demonstrate competence of the nine competencies and their respective practice behaviors (in field education), as required by CSWE's 2015 Educational Policy and Accreditation Standards. Because of the clinical focus of the MSW program (the School's only specialized option), the School field education evaluation utilizes both the generalist level practice behaviors outlined in the 2105 EPAS, as well as the specialized level practice behaviors that have been updated from the publication Advanced Social Work Practice in Clinical Social Work (CSWE, 2009) to measure real practice situations. Competency assessment at the required course-level measures both real and simulated practice situations for each of the nine competencies at both the generalist and specialized practice levels. Specific assignments, readings, tests and learning activities at the course level are utilized as part of the course level assessment evaluation. Thus, the assessment plan and procedures integrate written, oral, and observational methods in both classroom and field settings. Assessment is used to continually inform and promote change in the explicit and implicit curriculum to demonstrate program competence and foster improvement.

Assessment of competence for both measures is reviewed and discussed by all faculty at faculty meetings and the annual faculty retreat.

When, Where, and How Assessment Occurs

When:

Field: generalist competencies are assessed at the completion of the MSW's first internship. Specialized clinical competencies are assessed at the mid-point and end of the students' second internship.

Courses: specific assignments in all required classes for generalist and specialized competencies are assessed at the end of each semester.

Where:

Field: generalist and specialized competencies are assessed in the students' field placement.

Courses: generalist and specialized competencies are assessed in the university classrooms where courses are held.

How:

Field: Field instructors score students' Field Evaluation and Learning Activity Agreement form which assess generalist and specialized competencies. The Director of Field Education analyzes the students' scores and the Director reviews the scores. To demonstrate competence, students must score a 1 or above on 75% or more of the practice behaviors.

Courses: Faculty grade students' performance on written, oral, and observational tasks/assignments associated with each generalist and specialized competency (e.g. papers, tests). Students must score at least 80% on each competency task/assignment. Faculty send the office manager a list of students who did not meet the competency standard. They then remediate with students to achieve competence.

Measure 1: Field instructors' assessments of students' competence in their field

Generalist competencies, and their associated practice behaviors, are assessed at the completion of the MSW student's first internship, and the specialized-clinical competencies, and their associated practice behaviors, are assessed at the mid-point and end of the student's second internship by field instructors and the Director of Field Education. Each of these include holistic dimension(s) and area(s) of practice. Scores from the field instructor on the Field Evaluation and Learning Activity Agreement are then analyzed to determine competence. Students must score a minimum of 1 out of 3 in at least 75% of the practice behaviors for the student to demonstrate competency. This information is collected and maintained in the IPT system.

Measure 2: Student evaluation by faculty in course embedded assignments where competencies are taught

Each of the nine competencies are assessed in specific tasks/assignments in two required courses during their generalist practice year. They are again assessed in specific tasks/assignments in two required courses during their specialized practice year. Each of these include holistic dimensions and areas of practice. At the end of each semester, faculty send the office manager a list of students in the course who did not achieve competence on noted embedded assignments. These students then put together a plan to remediate in order to achieve a minimum of 80% out of 100% on noted assignment(s) to demonstrate competence.

Description of How Student Performance Meets Benchmark

Competency Benchmark Rationale: Our rationale for choosing 90% came from multiple faculty discussions, consulting with other social work programs, and the recommendation examples offered by CSWE EPAS. This number is commonly used throughout social work education and in other disciplines as a strong competency benchmark at the program level. While it allows for individual student variance for not meeting a competency, it does require that most students demonstrate competency in order to establish program level competence.

Outcome Measure #1 Benchmark Rationale:

The outcome measure utilized are scores from field instructor on Field Evaluation and Learning Activity Agreement. This agreement was developed after multiple stakeholder focus groups and faculty discussions.

Outcome Measure #2 Benchmark Rationale:

The rationale for choosing 80% as our benchmark for embedded assignments came from multiple faculty discussions, the C grade policy in the School of Social Work, and BYU Graduate Studies policy that a student graduate with a 3.0 GPA or better. As a faculty, we believe students need to demonstrate competency at a B- grade level or better to demonstrate competence. Thus, 80% was determined to be the best minimal indicator of competence.

How the program determines the percentage of students achieving the benchmark involves a three step process: 1) Determine the number of students who attained competence in field and in their coursework; 2) Calculate the percentage of students deemed competent from the program's total student population; and 3) Compare the percentage with pre-determined benchmark.
